



2022 NORTH FORK POOL, PARK AND RECREATION DISTRICT PARTICIPATION WAIVER

Use of the North Fork Pool, Park and Recreation District (the “District”) facilities and enrollment in its programs is subject to the rules and regulation promulgated by the District Staff.

District facilities may be closed to the public due to repair, maintenance, cleaning, or special events as determined by the District without refund of any pass portion to the members.

Pass & Membership Waiver & Refund Policy

REFUND POLICY: Pass refunds may be authorized for medical reasons, or employment transfer. Refunds will be prorated for part of the season already gone. Refunds may be requested by contacting the District Administrator.

A full refund will be given for programs or activities that are canceled by the District. If for any reason, a patron finds he/she cannot participate in a program or activity for which he/she is registered, a full refund should be requested in writing prior to the advertised registration deadline. In some cases, full refunds may be issued at the discretion of the District Administrator, if requested in writing prior to the conclusion of the program or activity. In some cases, you could be charged a \$5.00 service fee. Participant should be informed that a refund may take up to two weeks to be issued.

Activity Waiver & Policy

WAIVER FOR PARTICIPATION

All exercise and participation are done at the risk of the participant, and the District is not liable for personal injury, theft, or loss of property. You assume full responsibility for yourself and your family members for any injuries, damages, or losses which may occur to you and hereby fully release and discharge the District and its employees and volunteers from any claims, demands, or damages resulting from your use of the facility and equipment.

General Release and Waiver

By signing this agreement, I waive my right to bring any legal action now or at any time in the future to recover compensation or obtain any other remedy for any injury to myself or my property or for my death, however caused, arising out of my use of the District facilities and/or participation in the District activities. I further agree that I, my spouse, assignees, heirs, guardians, and legal representatives will not make any claim against, sue or attempt to attach the property of the District for any loss or damage resulting from my use of the District facilities and/or participation in the District activities. I am aware of the potential dangers incidental to recreational sports activity, that this is a release of liability, a waiver of my legal right to collect damages in the event of injury, death or property damage, and a contract between the District and me, and I sign it of my own free will.

I expressly agree that this release is intended to be as broad and inclusive as the State of Colorado will allow and that if any portion is held invalid, I agree that the balance shall, not withstanding, continue in full legal force and effect.

2022 Pool Bus Wavier

I authorize the District to transport my minor child in a company Bus or Van, driven by an individual authorized by the District. I understand my child is expected to follow all applicable laws regarding riding in a motor vehicle and is expected to follow the directions provided by the driver and/or staff or volunteer.

I have read, understand, and discussed with my child:

- (1) My child will travel in a motor vehicle driven by an adult and my child is to wear their safety belt during travel, if provided and applicable;
- (2) My child is expected to listen to supervising staff/driver, respect staff and other children, the vehicles they ride in, and the people they travel with during the trip;
- (3) My child is expected to follow all COVID-19 requirements including social distancing and wearing a mask, if required by the District or Federal Transportation Guidelines;
- (4) Riding in a motor vehicle may result in personal injuries or death from wrecks, collisions or acts by riders, other drivers, or objects; and,
- (5) My child is to remain in their seat and not be disruptive to the driver of the vehicle.

Please read and initial each statement below:

_____ I recognize participation in this activity, as with any activity involving motor vehicle transportation, my child may risk personal injury or permanent loss. I hereby attest and verify I have been advised of the potential risks, and I have full knowledge of the risks involved in this activity, and I assume any expenses incurred in the event of an accident, illness, or other incapacity, regardless of whether I have authorized such expenses.

_____ If a child misses the bus, it is the parents' or guardians' responsibility to provide transportation to or from the pool. Please instruct your children on procedures to follow if they miss the bus.

1. If the bus is missed in the morning, go home immediately.
2. Review the departure time of the bus with your child - they are responsible for boarding the bus at the correct time; District employees are not responsible for ensuring your child boards the bus.

3. If the bus is missed in the afternoon, know who to call for a pick up. **The District will not arrange alternative pick ups nor is responsible for children who miss the bus.**
4. Alternate stops will not be allowed.

Once the bus starts moving, it will not stop to pick up a late student.

_____ As a condition for the transportation received, I, for myself, my child, my executors and assigns, further agree to release and forever discharge the District and their agents, officers, employees and volunteers from any claim that I might have myself or that I could bring on my child's behalf with regard to any damages, demands or actions whatsoever, in any manner arising out of this transportation.

_____ Boarding the bus is the responsibility of the child. The District will not arrange for alternative transportation or act as an intermediary for alternative transportation.

_____ I realize it is my responsibility to deliver my child to a designated bus stop, and I assume full responsibility for my child getting to and from the bus stop safely. I am also aware that if my child misbehaves, my child may lose bus-riding privileges.
