- (3) My child is expected to follow all COVID-19 requirements including social distancing and wearing a mask, if required by the District or Federal Transportation Guidelines;
- (4) Riding in a motor vehicle may result in personal injuries or death from wrecks, collisions or acts by riders, other drivers, or objects; and,
- (5) My child is to remain in their seat and not be disruptive to the driver of the vehicle.

- 2. Review the departure time of the bus with your child they are responsible for boarding the bus at the correct time; District employees are not responsible for ensuring your child boards the bus.

3.	If the bus is missed in the afternoon, know who to call for a pick up. The District will not arrange alternative pick ups nor is responsible for children who miss the bus.
4.	Alternate stops will not be allowed.
