Skate Park Lease Agreement

Lease agreement needs to be renegotiated June 2020. We need to think about future role of NFPPR dependent on improvements from grant applications.

Board role is to listen and evaluate administrative suggestions rather than direct day to day activities. Further discussion is needed about public comments by board members.
